**3 Network of Networks Update**

RT update on ERSA meeting with DWP. DWP agreed need for Expert Reference Group (ERG) in Scotland. Call for members closed last week; 10-12 individuals interested. Consideration being given to how this group connects with Commissioning sub-group.

Youth Employment Group update from AM:

- Workstreams agreed. Timescales being planned by designated leads with mid-Sept as wrap-up.
- 19 attendees at first wider group meeting on Mon 4<sup>th</sup> Aug. Sam Windett gave update on UK YEG.
- AM flagged need for comms from NoN lead orgs to ensure sector are aware of NoN and sub-groups. Needs consistency. RT said this will be on agenda of next ESS meeting (next week).
- AM also producing NoN governance chart for SG (to be proposed for sign off at tomorrow's NoN meeting).

- TMcD flagged timescales and pace of decision-making; need to focus on the design and implementation of policy.

Commissioning and NOLB:

No representatives were present. To feedback at future meeting.

Feedback loop between sub-groups and TSEF: RT proposed discussion by postponed until next TSEF meeting due to low number.

Network of Networks expansion:

Social Enterprise Scotland Network (SENS) has strong desire to further engage and feed into the Network of Networks and become more actively engaged with TSEF and the Executive Group. Given the governance structure remains in development for now TSEF Exec Group are not taking on new members – will keep position under review.
